### Revenue:

4002 - Corporate Contributions	Funds received from corporations in support of Special Olympics
4003 - Organizations & Associations	Funds received from organizations and associations in support of Special Olympics
4007 - Individual Contributions	Funds received from individual donations in support of Special Olympics
4200 - Fundraising Events	Funds received due to a specific fundraising event
4205 - Souvenirs	Funds received from the sale of Special Olympics souvenir items
4206 - Concessions	Funds received from the sale of concession items
4280 - Shared Rebate Revenue	Funds received from regional fundraising events as a % raised
4400 - Registration Fees	Funds received for fees charged to attend athletic tournaments and camps

### Expenses:

6010 - Professional Fees	Costs incurred for umpires, referees and/or judges
6011 - Bank Charges	Costs incurred for service charges on banking accounts
6020 - Supplies	Costs incurred for the purchase of consumable supplies, such as office supplies
6025 - Equipment	Costs incurred for the purchase of sports equipment
6030 - Postage/Shipping	Costs incurred for the purchase of stamps, postage or shipping
6032 - Equipment Maintenance	Costs incurred for maintaining sports equipment
6034 - Equipment Rental	Costs incurred for renting equipment needed for fundraising and sporting events
6050 - Appreciation	Costs incurred for items given in appreciation of volunteers
6060 - Hospitality	Costs incurred for meals or beverages provided to volunteers
6101 - Facility Rental	Costs incurred for renting facilities for sporting and fundraising events
6150 - Advertising	Costs incurred for advertising
6161 - Printing	Costs incurred for printing, such as flyers or newsletters
7000 - Fundraising Expenses	Costs incurred for fundraising events
7033 - Raffle Items	Costs associated with a raffle
7060 - Souvenirs	Costs associated with the sale of items purchased for resale
7063 - Concessions	Costs associated with the sale of concessions
8000 - Athlete Awards	Costs incurred for medals, ribbons, plaques given to athletes at competitions
8010 - Athlete Entertainment	Costs incurred for entertainment provided for athletes at local program events
8030 - Athlete Transportation	Costs incurred for transportation to sporting competitions
8040 - Athlete Uniforms	Costs incurred for uniforms
8050 - Registration Fees	Costs incurred to participate in competitions
8100 - Housing	Costs incurred to provide athlete housing at competitions
8200 - Meals	Costs incurred to provide athlete meals at competitions
